The primary purpose of this book is to help you understand what is going on in Fourier Transform (FT) Nuclear Magnetic Resonance (NMR) spectroscopy. La sobreexplotación de los recursos pesqueros, la sobrecapitalización de las pesquerías, la eliminación de las rentas que generan a la sociedad y la creciente inquietud por la conservación de la biodiversidad marina, han motivado el desarrollo de líneas de investigación pesquera con un enfoque multidisciplinario, dinámico y precautorio. En este contexto, el análisis conjunto de factores biológicos, ecológicos y económicos surge como un tópico necesario a la hora de evaluar aquellas fuerzas que regulan la dinámica de una pesquería. Este documento desarrolla aspectos de la teoría bioeconómica dinámica a efectos de lograr un manejo sostenible de la actividad pesquera. Se define al manejo de un recurso pesquero como un proceso complejo que requiere la integración de su biología y ecología con los factores socio-económicos e institucionales que afectan al comportamiento de los usuarios (pescadores) y a los responsables de su administración. El libro es presentado en ocho Capítulos. El Capítulo 1 describe los supuestos básicos en la asignación óptima de los recursos naturales renovables, así como las características inherentes de los recursos pesqueros y las interdependencias humanas que determinan, en un régimen de acceso abierto, el fracaso en dicha asignación y en consecuencia su sobreexplotación. Se describe cómo el aprovechamiento de este tipo de recursos bajo acceso abierto enfrenta altos costos de



exclusión, altos costos de transacción (costos de información y vigilancia), generación de externalidades negativas y positivas y presencia de usuarios no contribuyentes. En el Capítulo 2 se discuten los puntos de referencia bioeconómicos obtenidos del análisis de pesquerías bajo supuestos de equilibrio. Para reflejar la naturaleza dinámica de las pesquerías se reconoce la necesidad de que las estimaciones de biomasa, captura y renta en el tiempo sean estimadas con las trayectorias dinámicas de la intensidad de pesca. Para realizar tales estimaciones se presentan modelos bioeconómicos dinámicos tanto globales como estructurales. En el Capítulo 3 se discuten y presentan las extensiones de estos modelos bioeconómicos mediante la incorporación de interdependencias ecológicas (i.e. competencia y depredación) y tecnológicas (i.e. competencia entre flotas con diferente poder de pesca, tecnología y costos unitarios del esfuerzo, pesquerías secuenciales con flotas artesanales e industriales que afectan diferentes componentes de la estructura de la población y pesquerías interdependientes con diferente especie objetivo). El precio del tiempo es incorporado en análisis a partir del Capítulo 4, en el cual se presenta el análisis intertemporal de pesquerías y se

estima el nivel de esfuerzo óptimo resultante de la utilización de diferentes tasas de descuento en la estimación del máximo valor presente neto. En el Capítulo 5 se introduce el enfoque de ciencia de sistemas para la construcción de modelos matemáticos aplicados al análisis bioeconómico que sustente los planes de ordenación de pesquerías. En el Capítulo 6 se discuten las alternativas de ordenación de pesquerías y las correspondientes ventajas y limitaciones en su aplicación al manejo pesquero de países en desarrollo. En el Capítulo 7 se introducen modelos bioeconómicos que relajan el supuesto de distribución homogénea de recursos pesqueros a través de la incorporación de la dimensión espacial en el análisis dinámico de pesquerías. Con un enfoque precautorio, en el Capítulo 8, se analizan el riesgo e incertidumbre presentes en las pesquerías marinas. Se introducen elementos básicos de teoría de decisiones y se presentan criterios de decisión que reflejan diferentes actitudes de aversión al riesgo en la ordenación de pesquerías. Se discuten métodos de análisis a través de tablas de decisión con y sin probabilidades matemáticas sobre la ocurrencia de posibles estados de la naturaleza que pudieran afectar el desempeño de las pesquerías.
