Financial experts Richard and Robert Michaud demonstrate that the limitations of MV optimization are not the result of conceptual flaws in Markowitz theory but unrealistic representation of investment information. estimation error in the optimization and rebalancing process. The text provides a non-technical review of classical Markowitz optimization and traditional objections.
