We describe a method, based on the theory of Macdonald-Koornwinder polynomials, for proving bounded Littlewood identities. Our approach provides an alternative to Macdonald's partial fraction technique and results in the first examples of bounded Littlewood identities for Macdonald polynomials. These identities, which take the form of decomposition formulas for Macdonald polynomials of type  $(R, S)$  in terms of ordinary Macdonald polynomials, are  $q, t$ -analogues of known branching formulas for characters of the symplectic, orthogonal and special orthogonal groups. In the classical limit, our method implies that MacMahon's famous ex-conjecture for the generating function of symmetric plane partitions in a box follows from the identification of  $GL(n, R), O(n)$  as a Gelfand pair. As further applications, we obtain combinatorial formulas for characters of affine Lie algebras; Rogers-Ramanujan identities for

affine Lie algebras, complementing recent results of Griffin et al.; and quadratic transformation formulas for Kaneko-Macdonald-type basic hypergeometric series.

Discrete mathematics, also called finite mathematics or Decision Maths, is the study of mathematical structures that are fundamentally discrete, in the sense of not supporting or requiring the notion of continuity. Most, if not all, of the objects studied in finite mathematics are countable sets, such as integers, finite graphs, and formal languages. Discrete mathematics has become popular in recent decades because of its applications to computer science. Concepts and notations from discrete mathematics are useful to study or describe objects or problems in computer algorithms and programming languages. In some mathematics curricula, finite mathematics courses cover discrete mathematical concepts for business, while discrete mathematics courses emphasise concepts for computer science majors.

The goal of this monograph is to prove that any solution of the Cauchy problem for the capillary-gravity water waves equations, in one space dimension, with periodic, even in space, small and smooth enough initial data, is almost globally defined in time on Sobolev spaces, provided the gravity-capillarity parameters are taken outside an exceptional subset of zero measure. In contrast to the many results known for these equations on the real line, with decaying Cauchy data, one cannot make use of dispersive properties of the linear flow. Instead, a normal forms-based procedure is used, eliminating those contributions to the Sobolev energy that are of lower degree of homogeneity in the solution. Since the water waves equations form a quasi-linear system, the usual normal forms approaches would face the well-known problem of losses of derivatives in the unbounded transformations. To overcome this, after a parilinearization of the capillary-gravity water waves equations, we perform several paradifferential reductions to obtain a diagonal system with constant coefficient symbols, up to smoothing remainders. Then we start with a normal form procedure where the small divisors are compensated by the previous paradifferential regularization. The reversible structure of the water waves equations, and the fact that we seek solutions even in space, guarantees a key cancellation which prevents the growth of the Sobolev norms of the solutions.
